

3.1. Participating Boxers

- Elite Men's & Women's between the Age of 1/1/1986 till 31/12/2007.

Elite Men's Weight Categories - 47-50Kg, 55Kg, 60Kg, 65Kg, 70Kg, 75Kg, 80Kg, 85Kg, 90Kg, +90kg.

Elite Women's Weight Categories - 45-48Kg, 51Kg, 54Kg, 57Kg, 60Kg, 65kg, 70Kg, 75Kg, 80Kg, +80kg.

- Reserve Boxers: If your National Federation is hesitating between two boxers, or simply wants to prevent any injury, please use the "Reserve Boxer" function in the database. This function will allow you to register more than one boxer in the same category, and you can choose last minute which boxer will participate even after registration ends (only one boxer will be allowed to compete in each category).

The process for obtaining a visa for Mongolia will be as follows:

- Team delegations that require entry visas will have their applications processed through the Mongolian Boxing Federation.
- All visas for the event will be issued in coordination with the Mongolian Boxing Federation.
- The cost of the visa will be USD 115 per person.

8. COMPETITION SYSTEM

- The Championships will be conducted according to current World Boxing Technical Rules.
- The Official Draw will be conducted by Swiss Timing system and Asian Boxing reserves the right to make changes in accordance with any situation.
- The Scoring System will be based on a "Ten Point Must System".
- There will be five (5) Judges for each bout in accordance with the electronic draw Scoring System.

10. BOXING ENTRIES CHECK

The Boxing Entries check is the final part of the event entry process. Asian Boxing and the LOC will inform Teams of their exact appointment time prior to the event as well as it will be displayed on the Team information board.

The Boxing Entries Check is mandatory for all Teams, and teams should make all necessary arrangements to arrive timely for their respective appointment. Each Team may appoint a maximum of two people to attend its Boxing Entries Check (e.g. Team Leader and the Team Doctor).

10.1 In order to be cleared for the competition, Teams must provide the following documents for each boxer, signed and completed as required:

- Athletes Copy of passport
- Record Book (with annual medical examination completed within the previous 12 months)
- Medical Certificate issued within the previous three months, signed by the National Federation doctor.
- Certificate of Gender Test – Male and Female

- Declaration of Non-Pregnancy Form (women boxers only), signed by the boxer.

10.2 Each team Delegation must also bring the following:

- National Flag 1X1.5 m
- National Anthem on USB Drive/ CD in mp3 format

10.3 Boxer's Uniform:

- The vest and shorts/skirt can be in the Boxer's respective national colours or in red or blue colour according to the Boxer's respective corner allocation
- Teams should review and ensure full compliance with the World Boxing Competition Rules, point 13.5, prior to arrival at the championship, to confirm that all uniforms meet the required standards.

10.4 Official boxing equipment

- All official boxing equipment used at Asian Boxing Championships will be provided exclusively by Asian Boxing through its official and exclusive equipment partner, Greenhill.
- No alternative equipment may be used unless expressly authorised in writing by Asian Boxing.

12. ACCREDITATION

For Team Delegations

All delegation members who have registered for the Asian Boxing Elite Boxing Championships Ulaanbaatar - 2026, through the official Asian Boxing Registration Form by February 11, 2026, will receive their accreditation upon payment of the accommodation fees to the Local Organizing Committee (LOC).

13. INSURANCE

All accredited participants must have their own travel, medical, repatriation, and liability insurance covering the entire event and travel period.

14. MEDICAL SERVICES

The LOC will provide first aid during the entire event period to any participant who suffers from a sports injury contracted during the event.

15. ANTI-DOPING

Doping control will be conducted in accordance with World Boxing Anti-Doping Rules and World Anti-Doping Code. According to WADA regulations, blood testing may be conducted during World Boxing Competitions.



16. IMAGE RIGHTS & VIDEO RECORDING

- Asian Boxing retains full and exclusive image, broadcast, and recording rights for all Asian Boxing Championships.
- Asian Boxing and its appointed partners are authorised to film and photograph the event for official, broadcast, promotional, and archival purposes.
- Photography by accredited media is permitted only in approved areas and in accordance with Asian Boxing Media protocols.
- Video recording of bouts or competition activity is not permitted unless expressly authorised in writing by Asian Boxing Media.
- All filming locations within the venue are restricted and controlled by Asian Boxing Media. Only media accredited through Asian Boxing will be permitted to capture images or access media areas. Media accreditation requests must be submitted directly to Asian Boxing.
